Report from the Director, Department of Health and Human Services, requesting authorization to enter into 2022 professional services contracts with community vendors for the Children, Youth and Family Services Division, by recommending adoption of the following:

**A RESOLUTION**

WHEREAS, per Section 59.52(31), Wisconsin State Statutes, the Director, Department of Health and Human Services, is requesting authorization to enter into 2022 Professional Services Contracts for the Children, Youth, and Family Services Division (CYFS); and

WHEREAS, the contracts reflect the procurement of the following services to support both the youth residing in the detention center, as well as CYFS staff, detention physician and medical services, and detention psychiatric nursing; training and technical assistance for the Bakari Program; as well as medical and pharmaceutical supplies, and medications; and

WHEREAS, there is no budgetary impact associated with this request, as funding for these contracts totaling \$1,076,838 is included in the 2022 Adopted Budget; and

WHEREAS, the Committee on Finance, at its meeting of December 9, 2021, recommended adoption of File No. 21-1020 (vote 7-0); now, therefore,

BE IT RESOLVED, the Director, Department of Health and Human Services, or her designee, is hereby authorized to enter into Professional Services Contracts in the amount of \$1,076,838 with the following organizations for the period beginning January 1, 2022, through December 31, 2022, in the amounts and terms enumerated as follows:
