

Overall Sentiment









Dear Finance Committee, I am writing in support of Supervisor Clancy's budget amendment to establish a full time nursing position within the Milwaukee County Housing Division to assist its Homeless Outreach Teams in addressing addiction issues among homeless individuals. Street Angels is currently serving 183 homeless individuals on our two mobile outreach routes (north side & south side); many are experiencing tremendous challenges with addiction as well as other health problems. We know from our other 'standing' outreach work in collaboration with the West Allis Fire Department, Community Medical Services, and Apostle Presbyterian Church that people struggling with addiction may take a long while to build the trust necessary to enter treatment. That said, we believe adding a dedicated nurse that would be a consistent, reliable part of the County's team could be of great benefit to our homeless friends.
