BACKGROUND

At its meeting for the March 2021 cycle, the Committee on Audit reviewed our audit report, "Former ROD's Willful Disregard for County Policies and Procedures and Cooperative Vendors Facilitate Development of a "Pot of Gold" for Improper Use of County Funds," issued in February 2021. The resolution noting County Board concurrence with the report recommendations was adopted.

to include the Department of Administrative Services (DAS) comments describing its progress toward implementing Recommendation 8, the single open recommendation out of the ten from our audit report.

As noted in its status report update to Recommendation 8, DAS management is working on several other contract-related ordinance updates due to changes at the State and Federal government and wants to bring all changes forward together.

This status report is informational. Due to the remaining efforts required to fully implement Recommendation 8, we plan to facilitate submission of DAS management's next status report for the June 2026 committee meeting cycle, or sooner if implementation is completed at an earlier time.
