- A. The Airport Division of the Milwaukee County Department of Transportation requests the abolishment of 1.0 FTE vacant Airport Assistant Manager (pay grade 30M), 2.0 FTE vacant Airport Operations Coordinator 1 (pay grade 22), and 1.0 FTE vacant Airport Operations Coordinator 2 (pay grade 25) positions, and create 4.0 FTE Airport Operations Supervisor (paygrade 28M) positions.
- B. The estimated fiscal impact associated with the create action is an increase of \$11,923 in prorated salary for 2020 (for 13 pay periods) and \$23,847in annual salary for 2021. The calculated cost assumes the newly created positions are filled at Pay Range 28M; Step 3 compared to the pay ranges and steps of the abolished positions at the time they were vacated. There is no tax levy impact to this change.
- C.There is no direct impact in 2020 because the Airport will cover any changes with airline fees. It is anticipated the Airport will roll new costs and savings into their 2021 budget moving forward.
- D. Assumptions include: all positions being abolished are currently vacant, and all new positions are filled at pay grade 28m.
