A. The resolution would increase the contract with First Transit by \$115,000, from \$1,510,940 to \$1,625,940, to align the contract with actual service demand.

B. A 2023 purchase of service contract amendment of \$115,000 with First Transit is requested to be funded with a State of Wisconsin 2023 plan year contract, including new Older Americans Act ARPA Title III-B Supportive Services grant funds (File 23-421).

C. This amendment will have no tax levy impact. The 2023 amended budget increase is more than offset with new 2023 Older Americans Act ARPA Title III-B Supportive Services grant funds and traditional Older Americans Act grant funds.

D. No assumptions were made.
