WHEREAS, as an added contribution to Milwaukee County's housing goals, City Wise will list subsidized housing units at no cost to participating landlords, thereby supporting access to affordable housing options; and

WHEREAS, the Committee on Health Equity, Human Needs, and Strategic Planning, at its meeting of May 16, 2025, recommended adoption of File No. 25-376 (vote 3-0); now, therefore,

BE IT RESOLVED, that the Milwaukee County Board of Supervisors hereby supports the partnership between Milwaukee County's Department of Health and Human Services Housing Division and City Wise Software LLC and recognizes this initiative as an innovative and equitable tool to connect residents with available rental housing; and

BE IT FURTHER RESOLVED, that the County Board encourages the continued development and promotion of this platform to improve housing accessibility, increase transparency in the rental market, and support the County's broader housing stability goals.
