REQUEST

The Superintendent, Milwaukee County House of Correction, is requesting authorization to waive Section 9.05(3) (a) of the Milwaukee County Code of General Ordinances, to allow Gregg Miliacca, former Correctional Officer Lieutenant, to perform work for the County as a contractor.

POLICY

9.05(3)(a) of the Ethics Code, which states no former County employee, for twelve (12) months following the date on which he/she ceases to be a County employee, shall, for compensation, on behalf of any person other than a governmental entity, provide any contractual services to the County

BACKGROUND

Gregg Miliacca, former Correctional Officer Lieutenant, recently retired and was hired by ICSOLUTIONS (ICS) as their Wisconsin Account Manager. Gregg Miliacca will be responsible for managing existing ICS communication contracts at Wisconsin Department of Corrections and Milwaukee County. ICS lost their last Account Manager and Gregg Miliacca's knowledge of Milwaukee County would be a valuable asset to ICS.

waver of Section 9.05(3) (a) of the Milwaukee County Code of General Ordinances, to allow Gregg Miliacca, former Correctional Officer Lieutenant, to perform work for the County as a contractor.
