
DESCRIPTION OF FISCAL EFFECT

The attached resolution provides clarity to administrators in relation to some compensation and fringe benefits for members of non-public safety worker certified bargaining units. These non-public safety worker certified bargaining units include: the Association of Milwaukee County Attorneys (AMCA), the International Association of Machinists and Aerospace Workers (IAMAW), the Milwaukee Building and Construction Trades Council AFL-CIO (Trades), the Technicians, Engineers and Architects of Milwaukee County (TEAMCO), and the Federation of Nurses and Health Professionals (FNHP). The resolution is a temporary measure until such time as the County Board reviews and adopts ordinance amendments addressing the matters on a permanent basis. The impact of the resolution is to maintain the status quo in terms of the treatment of some compensation and fringe benefits for these employees and as such does not contain a fiscal impact.
