Office of Emergency Management requests to create 1.0 FTE MIH Captain, Pay Grade NR27.

## **BACKGROUND**

The EMS Division has been awarded significant funding from the Opioid Settlement Fund project and is now positioned to create a Mobile Integrated Health team focused on chronic and acute disease prevention, providing patients with an upstream engagement in their healthcare.

This position will fill in gaps in Milwaukee County as only 6 of the 19 municipalities have access to a Mobile Integrated Health Program. Objectives Impacted: 2A, 2B, 2C, 3A, 3B, 3C.
