 - B. - A. The Office of the Comptroller is requesting approval of the attached parameters resolution for the issuance of a not-to-exceed (“NTE”) amount of \$210,350,000 of general obligation bonds (“Bonds”) and/or general obligation promissory notes (“Notes”) to finance various capital projects that have already been approved by the County Board and County Executive. The resolution also delegates the bid opening and approval of the winning bidder for the sales of the Obligations to the Comptroller. The Comptroller’s approval is limited to sale results that fall within the parameters outlined in the resolutions.
 - B. The estimated debt service costs for the not-to-exceed amount of \$210,350,000 of Corporate Purpose Bonds/Notes is \$299,148,000 which includes \$88,798,000 of interest costs.
 - C. There is no current year budgetary impact since the debt payments will not begin until 2024 and the bond/note revenues are already budgeted for the individual projects. The 2024 Budget will need to include principal and interest expenses for the 2023 debt that is being issued. The estimated debt service expenses for 2024 from the bonds and notes issued in 2023 is approximately \$8,312,000.
 - D. The maximum true interest cost is 6.0 percent. The costs of issuance will not exceed the federally allowable 2% of the par value of the bonds. The estimated total debt service is based on seven (7) separate schedules.
