
Approval of this resolution will authorize and direct the Department of Administrative Services to process an appropriation transfer to establish the expenditure and revenue authority for the construction of an artistic bus shelter in Bay View.

This resolution anticipates total construction costs of \$150,000 to be offset with \$120,000 in Federal Transit Administration (FTA) Urbanized Area Formula Funds and \$30,000 from the Bay View Business Improvement District #44 as the required 20 percent local match requirement.

Upon securing the FTA funding, the previous resolution, File No. 11-595, which allocated \$50,000 in Public Art Program funds toward the bus shelter project, will be rescinded and these monies available for other purposes.
