AMENDMENT #1 to the Professional Service Agreement Milwaukee County Fatherhood – Family-Focused, Interconnected, Resilient, and Essential (Fatherhood FIRE) Project

This AMENDMENT #1 to the Fatherhood FIRE Professional Service Agreement (the "Agreement") dated July 1, 2024, is between Milwaukee County, a Wisconsin municipal body corporate, represented by its Department of Health & Human Services Department, Child Support Services Division (the "County" or "CSS") and United Community Center (the Contractor or UCC), combined to be considered Parties to this Agreement ("Parties").

ACCORDINGLY, it is agreed to, by and between County and Contractor, that the contractor's activities shall include, but not be limited to, all provisions contained in the original contract effective September 30, 2023, except

- Section 2. Order of Precedence is amended as follows:
 To include the documents listed below in order of precedence and are incorporated by reference.
 - 2.2 Child Support Services and United Community Center Extended Memorandum of Understanding (MOU) and Statement of Assurances for the Family-Focused, Interconnected, Resilient, and Essential (Fatherhood FIRE) Funding Opportunity (Exhibit A)
 - 2.6 Child Support Services Fatherhood FIRE Budget Detail (Exhibit B)
- Section 4. Term and Termination is amended as follows:
 - 4.1 Term.

The term of the Agreement shall be extended through September 29, 2024.

- Section 5. Compensation & Payment.,
 - 5.1 Payment Terms is amended as follows:

The County shall compensate the Contractor for work performed as a fixed fee. The total compensation to the Contractor for services performed under the Agreement shall increase by \$21,625.00 not exceed \$120,625.00 for the period of 9/30/2023 – 9/29/2024, unless agreed to by the County in writing. Compensation is contingent on the annual renewal of Financial Assistance Award No. 90ZJ0010-04, a discretionary grant by the Administration of Children and Families (ACF) of the U.S. Department of Health and Human Services to CSS.
