  - A. An extension of the Ready to Work Initiative (R2W), which was previously adopted in the 2012 Budget, is requested to be funded by the 2014 Economic Development Fund created in the 2014 Budget.
  - B. The funds to be used for this extension have been earmarked in the 2014 Budget contingent upon the amount of generated revenues from county land sales, thus causing no current year fiscal impact.
  - C. The funds used for a 2014 extension of R2W will only be expended to the extent that revenues have been generated from 25% of proceeds collected from county land sales, creating a net fiscal impact of zero; this extension will have no future budget year impacts.
  - D. See B above.
