**SUBJECT: Appointment of Members to an Administrative Determination  
Review Committee**

Sections 110.03 and 110.07(a) of the Milwaukee County Code of General Ordinances (the Code) provide that any person whose rights, duties, or privileges have been directly adversely affected by a determination of a Milwaukee County (the County) authority may appeal such determination to the appropriate Milwaukee County Board of Supervisors' (County Board) standing committee. Such an appeal is to be heard by either the standing committee or a review committee with members appointed by the standing committee chairperson and confirmed by the committee.

The Committee Coordinator for the Committee on Finance and Audit is in receipt of an appeal filed by Mr. Clarence Johnson, Executive Director of Wisconsin Community Services (WCS), dated February 6, 2019, regarding the Alternative Sanctions Program.

Therefore, pursuant to Section 110.07(d) of the Code, and subject to confirmation of the Committee on Finance and Audit, I am pleased to appoint the individuals listed below to the Administrative Determination Review Committee to conduct a review and render a decision on an appeal to the County Board standing committee of a determination made by County authorities.
