BACKGROUND

EMS Division staff have achieved preferred and established upgrades in certification in line with the OEM goal of advancing patient-centered care and education in the county. Promoting providers to practice their increased medical scope of practice to its fullest, approved, progressive extent benefits Milwaukee County and its citizens, equitably and effectively.


