

Request to extend and amend the Memorandum of Agreement with Froedtert Memorial Lutheran Hospital, Inc. (Froedtert and Froedtert Hospital) and the Office of the Sheriff (MCSO) to provide law-enforcement related services at the premises of Froedtert Hospital in the Emergency Department, by recommending adoption of the following:

**A RESOLUTION**

WHEREAS, the Milwaukee County Sheriff’s Office (MCSO) is requesting authorization to extend and amend a July 2016 Agreement with Froedtert Memorial Lutheran Hospital, Inc., (Froedtert) for the purpose of providing law enforcement-related services, including but not limited to: uniformed security services, marked squad operations, critical incident response, and investigations for the period beginning March 31, 2020, and ending midnight on March 31, 2021; and

WHEREAS, MCSO shall station a Deputy Sheriff to perform law enforcement-related services during all three shifts, 24-hours per day, 365 days of the year, on or about the premises of Froedtert with the primary location being the Froedtert Emergency Department, unless other activity on the premises require the Deputy Sheriff to leave his or her post; and

WHEREAS, the rates per hour have been approved by MCSO Fiscal Administration, and agreed upon by Froedtert, but are subject to change per Milwaukee County’s contracts with the Milwaukee Deputy Sheriff’s Association, and the budgets for each fiscal year; and

WHEREAS, the current rates are as follows:

34 WHEREAS, this Agreement shall automatically continue in full force and effect  
35 from year-to-year under the terms and conditions provided herein, unless terminated by  
36 either party upon 90 days prior written notice following expiration of the first contract  
37 year; and

39 WHEREAS, Section 59.52(31)(c), Wisconsin State Statutes, requires the  
40 Milwaukee County Board of Supervisors to authorize a contract for services with a value  
41 greater than \$300,000; and

43 WHEREAS, the Committee on Finance and Audit, at its meeting of March 18,  
44 2020, recommended adoption of File No. 20-202 (vote 7-0); now, therefore,

46 BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby  
47 authorizes the Chief Deputy, Office of the Sheriff, to extend and amend a July 2016  
48 Agreement with Froedtert Memorial Lutheran Hospital, Inc. (Froedtert), to provide a  
49 uniformed law enforcement presence on or about the premises of Froedtert during all  
50 three shifts, 24-hours per day, 365 days of the year, for the period beginning March 31,  
51 2020, and ending midnight on March 31, 2021, with the Agreement then continuing in  
52 full force and effect from year-to-year unless terminated by either party upon written  
53 notice of 90 days following expiration of the first contract year.
