### **REQUEST**

The County Executive respectfully requests acknowledgment, acceptance, and appropriation of \$15,879,000 in State of Wisconsin ARPA allocation to Milwaukee County primarily to address backlogs in the court system.

#### **BACKGROUND**

After extensive negotiation between the Administration and State of Wisconsin, the Governor's office awarded Milwaukee County \$15,879,000 in state American Rescue Plan Act funds. The vast majority of these funds – almost \$15 million – will go directly to the Court system in order for Courts to more efficiently process and resolve the historic backlog in cases resulting from COVID-19. The remaining allocation is earmarked to go to expanding staffing of GPS monitoring programs for individuals awaiting trial, as well expanding employment and vocational preparedness programs at the House of Correction. The full breakdown of funds is as follows:
