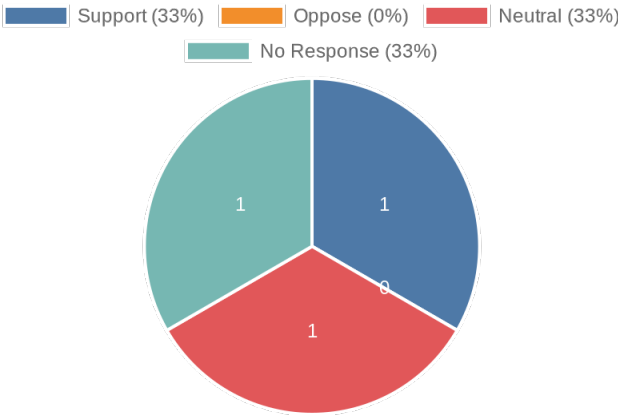

Overall Sentiment



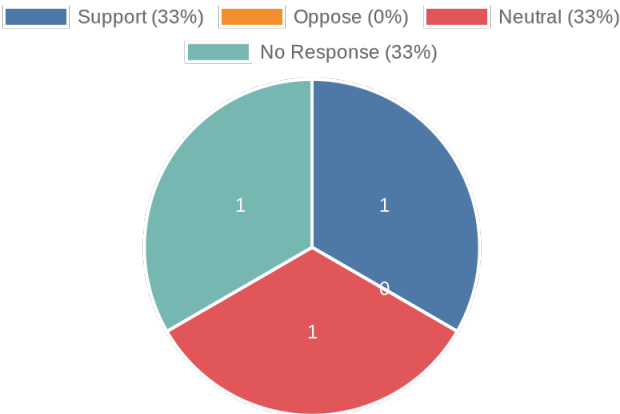

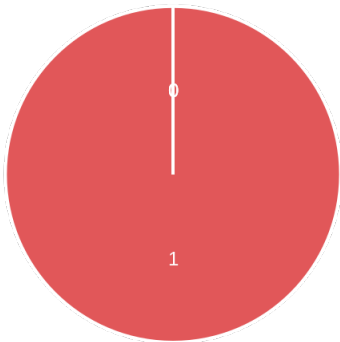
Overall Sentiment

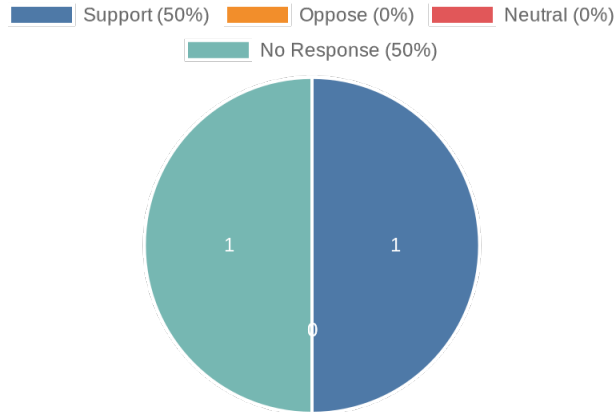
Overall Sentiment

This audit showed some truly alarming issues in the jail, particularly with how those with mental health issues or experiencing suicidal thoughts are treated.

While the sheriff and jail staff can insist they'll implement changes from this action plan, it remains clear that some form of community accountability is sorely needed.

People are continuing to die in the jail since this audit, and serious accountability measures need to be put into place. An all elected civilian accountability council would be the best way to go about this - not a hand selected board like Sheriff Ball has suggested.

And while there has been great pushback against adopting a policy similar to SOP 575, I still believe this needs to be much more seriously considered until a meaningful policy can be put into place, that does not leave grieving families in the dark. Transparency and accountability go hand in hand, and I believe this is a crucial part of addressing the ongoing issues in the jail.

The issues of the jail cannot be remedied by actions within the jail alone. Legislative components must be considered and implemented to address inadequacies in the Ch 51 process, mental health courts, and the availability of resources within Milwaukee County. The jail is effectively the largest mental hospital in the county. This fundamental element is at the root of all the challenges faced there.
