
- A. Briefly describe the nature of the action that is being requested or proposed, and the new or changed conditions that would occur if the request or proposal were adopted.

 - A. Approval of this resolution will request the Department of Parks, Recreation, and Culture to collaborate with representatives from the University of Wisconsin-Milwaukee and the Friends of the Monarch Trail to assess the environmental impacts and scope of work of constructing a proposed "Emerald Parkway" on the County Grounds that could potentially affect existing critical species habitats and stormwater management infrastructure, and to provide an informational report to the County Board. The resolution also requests for specific questions to be addressed in the report, which should be submitted to the County Board in time for the March 2017 cycle, and also requests that a detailed map be included that outlines the ownership of the parcels of land on the County Grounds.
 - B. This resolution is a request for information, and would therefore have no direct fiscal impact beyond the existing staff time needed to assemble and submit the report.
 - C. This resolution would have no budgetary impact on the current or subsequent year, as it is a request for information.
 - D. No assumptions or interpretations were made at the time this resolution was drafted.

¹ If it is assumed that there is no fiscal impact associated with the requested action, then an explanatory statement that justifies that conclusion shall be provided. If precise impacts cannot be calculated, then an estimate or range should be provided.
