Courts is requesting to create 12.0 FTE with State ARPA funding to expand Court operations and reduce the backlog. It is anticipated the positions will be filled June 1, 2022, for a current year cost of \$\$369,7414. The annual cost of the twelve positions is \$633,796. All position cost will be offset with State ARPA grant funding for a zero impact to tax levy. The 12.0 FTEs will serve as support staff for 3 judges in the felony division, 1 judge in the misdemeanor division, and 1 judge in the domestic violence courts.

The cost for the 12.0 FTEs is based on filling the positions at the midpoint of the salary range. It is assumed the positions will be filled June 1, 2022.
