

Overall Sentiment







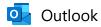
