A. The Director of the Department of Health and Human Services (DHHS) is requesting authorization to enter into 2023 contracts for Aging and Disabilities Services. This includes contracts with the following providers: Broadscope for employment services, Community Advocates to support the Interim Disability Assistance Program (IDAP) as well as a contract with Easterseals Southeast Wisconsin for the provision of recreational programs for individuals with disabilities.

B. Approval of this request will result in total expenditures of \$508,057 for 2023.

C. There is no tax levy impact associated with approval of this request in 2023 as funds sufficient to cover associated expenditures are included as part of the 2023 Aging and Disabilities Services Budget.

D. This fiscal note assumes expenditures will not exceed the amounts authorized for these contracts.
