Dr. Litwack is an advanced practice certified family nurse practitioner. Her main responsibilities in patient care include implant and medical management of patients. Dr. Litwack is also the Dean and Professor of Nursing at the University of Wisconsin-Milwaukee College of Nursing. Using the North Central Curriculum, and in partnership with Waukesha County Technical College (WCTC), she created the community paramedic program in 2014. This program serves as the foundational piece of initial education for the community paramedic including core content specific to the role of the community paramedic, content-specific to community and public health, cultural competency community assessment, chronic disease assessment, teaching and management.
