In connection with the performance of work under this contract, Milwaukee County and the contractor agree that in the event Milwaukee County acquires new or additional buildings requiring janitorial services, the contractor shall have the opportunity to submit a bid for the provision of janitorial services for such new or additional building;

In connection with the performance of work under this contract, Milwaukee County and the contractor agree that in the event Milwaukee County relocates any of its operations from one building currently covered by this contract to another building currently not covered by this contract, that the contractor shall continue to provide janitorial services at the new location at comparable rates;
- 6. In connection with the performance of work under this contract, Milwaukee County may terminate this contract for any reason or for no reason at all upon 60 days' advance written notice to the contractor;
