- A. The Milwaukee County Medical's Examiners Office (MCMEO) is requesting adoption of a resolution which will abolish one FTE Lead Forensic Toxicologist and create one FTE Quality Assurance Manager.
- B. The new position is budgeted at approximately \$90,000 and have been calculated at positions starting in low-end of the range.
- C. The position has been fully funded with the approved 2025 MCMEO's budget. The new position will save the county money due to the fact it has a lower pay grade.
- D. The position is assumed to be hired in the lower end of the pay scale. If the applicant has higher qualifications and requires a higher starting salary the pay will still be lower than the Lead Forensic Toxicologist role that its replacing.
