From the Chief Judge, First Judicial District, Combined Court Relative Operations, requesting authorization to increase an existing contract for a Safety and Justice Challenge Project Manager position by \$29,893, from \$134,519 to \$164,412, and to extend the contract for the position by four months, from October 31, 2018, to February 28, 2019, by recommending adoption of the following:

A RESOLUTION

WHEREAS, on April 13, 2016, Milwaukee County (the County) received from the John D. and Catherine T. MacArthur Foundation (MacArthur Foundation) a funding award notice for the Safety and Justice Challenge Phase II Implementation in the amount of \$2,000,000; and

WHEREAS, the award period is from May 1, 2016, to April 30, 2018, with the possibility to extend an additional year; and

WHEREAS, on May 26, 2016, the Milwaukee County Board of Supervisors (County Board) adopted File No. 16-271, which authorized the Chief Judge to accept the Safety and Justice Challenge Phase II Implementation grant from the MacArthur Foundation (16-1601-150542-CJ) for the Safety and Justice Challenge Phase II; and

WHEREAS, on December 15, 2016, the County Board adopted File No. 16-679, which authorized the Chief Judge to issue an 18-month contract for the Safety and Justice Challenge Project Manager not-to-exceed \$127,500; and

WHEREAS, on May 25, 2017, the County Board adopted File No. 17-349, which authorized the Chief Judge to increase the total 18-month contract amount for the Safety and Justice Challenge Project Manager by \$7,019, from a total of \$127,500 to \$134,519; and

WHEREAS, Milwaukee County will increase and extend the 18-month contract for the Safety and Justice Challenge Project Manager by \$29,893, from a total of \$134,519 to \$164,412, for a total of 22 months ending February 28, 2019; and

WHEREAS, the Committee on Finance and Audit, at its meeting of May 17, 2018, recommended adoption of File No. 18-357 (vote 7-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby authorizes the Chief Judge, First Judicial District, Combined Court Related Operations, to increase an existing contract for a Safety and Justice Challenge Project Manager position by \$29,893, from \$134,519 to \$164,412, and to extend the contract for the position by four months, from October 31, 2018, to February 28, 2019.
