
## DESCRIPTION OF FISCAL EFFECT

Approval of this resolution/ordinance will amend the ethics code ordinances to provide for the filing of a Statement of Economic Interest (SEI) by candidates for county elected offices on the Friday following the date for filing of nomination papers rather than on the same day. The Election Commission shall provide the Ethics Board with a copy of all filings by county elected officials who have filed to be a candidate for office.
  - B. The proposed change is not anticipated to require an expenditure of funds, but staff time will be necessary.
  - C. No impact on the budget is expected. The requirements imposed by this ordinance can be accomplished within existing appropriations for staff.
  - D. No assumptions were used.
