Requesting Authorization to Execute a Four-Year Contract with Word
Systems, Inc. for the Continued Service of Digital Voice Recordings of the
9-1-1 Communications Center for the Period of January 1, 2018 through

December 31, 2021

Issue:

The Office of the Corporation Counsel opinion of March 3, 2017, regarding procurement services contracts under Chapter 32 of the Milwaukee County Ordinances, requires full County Board approval on multi-year budget contracts.

Background:

Word System, Inc. has been the contractual provider of a proprietary digital voice recording system known as NICE Inform for 9-1-1 Communications for six years. OEM executed a one year Phase 1 agreement with Word Systems, Inc. on December 20, 2016 to replace end-of-life hardware and to enhance disaster recovery survivability through redundancy.

The digital voice recording system provided by Word Systems, Inc. supports life-saving actions in the 9-1-1 and EMS operations center, to include recordings of 9-1-1 emergency calls and 9-1-1 dispatcher-assisted CPR calls; radio transmissions with MCSO Deputies, District Attorney Investigators, countywide paramedics, and, physicians from the Medical College of Wisconsin.

The Phase 1 total cost of \$40,665 to fund this support is included in the 2017 IT Spend budget. The Phase 2 annual cost of \$44,405 is included in the 2018-2021 IT Spend budget. The total value of the proposed Phase 2 extension will not exceed \$177,620 over four years.

Recommendation:

It is recommended to authorize the Director of OEM to execute a Phase 2 four-year contract with Word Systems, Inc. for the period of January 1, 2018 through December 31, 2021 in order to ensure continuity of service for digital voice recordings of the 9-1-1 Communications Center for a yearly not-to-exceed value of \$44,405 and a total contract value of \$177,620.
