

 - B. - A. The Office of the Comptroller is requesting the approval of the attached authorizing resolution and parameters resolution for the issuance of a not-to-exceed amount of \$15,500,000 of Corporate Purpose Refunding Bonds to refund the balance of the outstanding debt for the \$31,595,000 Series 2006A General Obligation Corporate Purpose Bonds (Series 2006A Bonds). The attached resolution authorizes the issuance of the bonds and provides parameters for the issuance and delegates approval of the sale of the bonds to the Comptroller. The Comptroller's approval is limited to results of the sale that fall within parameters outlined in the resolution. An informational report will be submitted to the Finance, Personnel, and Audit Committee to communicate the final results of the bond sale.
 - B. The estimated net present values savings for the refunding is \$1,195,712 (or 7.88%). Total estimated debt service for the refunding is \$16,785,433. The not-to-exceed amount includes expenditures for the costs of issuance.
 - C. An administrative transfer will be submitted to the Department of Administrative Services to adjust the Org. Unit 9960 General Debt Service budget in order to pay costs of issuance. The revenue is included in the bond issue amount.
 - D. The not-to-exceed amount will be \$15,500,000. The costs of issuance will not exceed the federally allowable 2% of the par value of the bonds. The minimum net present value savings from the issuance will be 3%.
