11 The County Board of Supervisors of the County of Milwaukee does ordain as
12 follows:

14 **SECTION 1.** Section 17.30(2) of the General Ordinances of Milwaukee County is
15 hereby amended as follows:

17 **17.30. - Confirmation of appointments to certain unclassified positions and terms**
18 **of such appointments.**

20 (2) In accordance with subsection (1) of this section all appointments to
21 positions of department heads in the unclassified service and appointments to all
22 management positions in the unclassified service responsible for a function which could
23 organizationally be structured as a separate department, shall require confirmation by
24 the county board and shall serve a term of office which commences upon the date
25 approved by the county board and expires six (6) months after expiration of the term of
26 office of the county executive or county board chairperson in office at the time of
27 appointment. The following positions shall be subject to this provision:

30 **SECTION 2.** Section 17.30(6) of the General Ordinances of Milwaukee County is
31 hereby amended as follows:

33 **17.30. - Confirmation of appointments to certain unclassified positions and terms**
34 **of such appointments.**

35 ~~(6) After January 1, 2009, appointments to the position of Executive director~~
36 ~~3—House of correction superintendent shall be made by the sheriff. Appointees to the~~
37 ~~position of Executive director 3 - House of correction superintendent or to any~~
38 ~~comparable successor position, however denominated, the primary duties of which~~
39 ~~involve the administration of the house of correction, shall be supervised by and serve~~
40 ~~at the pleasure of the sheriff.~~

42 (6) Appointments to the position of Executive director-- 3 House of Correction
43 Superintendent shall be made by the County Executive. The County Executive shall
44 supervise the administrative duties of the House of Correction Superintendent or any
45 comparable successor position, however denominated. The Superintendent for the
46 House of Correction supervisor shall serve at the pleasure of the County Executive.
