- A. If approved, Milwaukee County Parks will enter into a ten-year lease extension with Mary-Bart, LLC, also known as The Bartolotta's Restaurants ("Bartolotta's"), for the operation of Lake Park Bistro. Bartolotta's is committed to \$300,000 of improvements to replace the flooring in the kitchen and remodel the kitchen. The current lease expires in 2025 and this will extend that lease to 2035.
- B. No direct costs, savings, or anticipated revenues in the current year as the lease does not expire until 2025 and revenues are already budgeted. Milwaukee County will realize a benefit with Bartolotta's investment because it does not deplete the Lake Park Trust Fund, maintains a historic structure, and provides important upgrades to the kitchen.
