

Also, maintenance for the area will continue to be included in the established park maintenance staff duties. Therefore, this will result in no fiscal impact for Milwaukee County.
 - C. As stated in B, since any signage associated with this item is expected to be covered by private donations, this item will have no budgetary impact for 2014 or subsequent years.
