 - A. Requesting to Abolish 1.0 FTE Air Service Director (Vacant) and to Create 1.0 FTE Airport Air Service Manager position in the Milwaukee County Department of Transportation – Airport Division.
 - B. Abolishing the vacant position and creating the new position is expected to be cost neutral because the position being abolished is already included in the Airport's current operating budget.
 - C. Abolishing the vacant position and creating the new position is not expected to result in a budgetary impact. The position being abolished is already included in the Airport's 2026 operating budget at a higher salary range than the newly created position.
 - D. The Current Year (2026) estimates in the expenditure and revenue table of this fiscal note assume the requested position is filled at an estimated annual salary of \$90,000 prorated at 13 pay periods for a cost of \$45,000 for the remainder of 2026.

The Subsequent Year (2027) estimates in the expenditure and revenue table of this fiscal note assume the requested position is filled for the entirety of 2027 at an estimated annual salary of \$90,000. The Subsequent Year's funding for this position will be included in the Airport's 2027 requested operating budget.

¹ If it is assumed that there is no fiscal impact associated with the requested action, then an explanatory statement that justifies that conclusion shall be provided. If precise impacts cannot be calculated, then an estimate or range should be provided.

² Office of Economic Inclusion (OEI) review is required on all professional service and public work construction contracts.
