WHEREAS, the current cost estimate of the BRT project is \$40,000,000 and a 7 percent amount of committed funds would be \$2,800,000; and

WHEREAS, the County, MCTS, and Southeastern Wisconsin Regional Planning Commission have allocated \$610,000 for the contract with AECOM for planning work associated with planning and documentation work associated with the development of the BRT project; and

WHEREAS, MCTS has sufficient 5307 Federal formula funds available in the amount of \$2,190,000 that could be used to support the BRT project; and

WHEREAS, the allocation of these funds would allow the County to submit for project development, and if for some reason the project development request was denied or the BRT project did not move forward, the amount of unspent 5307 Federal formula funds allocated for BRT could be repurposed for future transit capital needs; and
