A. The Executive Director of the Department of Health and Human Services (DHHS) is requesting authorization to enter into a three-year (2027-2029) cooperation agreement with non-entitlement Milwaukee County jurisdictions for the purpose of receiving HUD funding as an urban county. The term of the cooperation agreement will have an automatic renewal. Participating municipalities will have the option every three years to confirm or decline participation in the urban county.

B. Milwaukee County receives approximately \$1.6 million each year to conduct community development and housing activities. Administrative costs, as required by HUD, can only amount to less than 20 percent of the grant. The remainder of the grant is divided equally between the County and the participating municipalities.

C. The report authorizes Milwaukee County to accept the grant. These funds are included in the Housing Services budget so there is no fiscal impact.

D. No further assumptions are made.
