A RESOLUTION

WHEREAS, Section 59.26(1), Wisconsin State Statutes, makes provisions for counties under civil service to allow the Sheriff, in conformity with county ordinance, to grant leaves of absence to deputies for appointment to higher positions; and

WHEREAS, on September 29, 2005, the Milwaukee County Board of Supervisors (County Board) created Section 17.193 of the Milwaukee County Code of General Ordinances (the Code), to provide a mechanism for the Sheriff to grant leaves of absences; and

WHEREAS, under Section 17.193, the Code, the Sheriff may not grant a leave of absence until the Sheriff first secures the consent of the County Board by resolution duly adopted by the County Board; and

WHEREAS, granting leaves will enhance the Sheriff’s ability to administer his/her office efficiently and appoint subordinates in a manner most effective in fulfilling the statutory and constitutional duties of the office; and

WHEREAS, the Sheriff requests a continued leave of absence for the following employee effective immediately upon adoption of resolution and appointment to the unclassified position:
