*Background: Individuals who applied by January 24<sup>th</sup>, 2024, to serve in one of the 2024 term vacant districts (2, 3, 8, 11, and 17) were scored by the members of the Youth Commission Leadership Committee. In cases where a member of the Leadership Committee knew an applicant personally, the Youth Commissioner(s) recused themselves from voting. This action to change the scoring from the Committee on Governance, Finance, and Evaluation to the Leadership Committee per the authority provided to the Co-Chairs to make decisions regarding the application process between meetings.*

*Proposed: The Milwaukee County Youth Commission respectfully requests that the Milwaukee County Board of Supervisors amends Chapter 106.03(4) of the General Ordinances to add a permanent at-large seat on the Milwaukee County Youth Commission to be occupied by a young person aged 14-18 in Milwaukee County who is experiencing housing insecurity at the time of application.*
