SUBJECT: County Facilities Planning Steering Committee Review of 2023 Capital Requests

BACKGROUND

The County Facilities Planning Steering Committee (CFPSC) was formed to provide a strategic perspective to decisions regarding County facility needs. Specifically, as stated in the current CFPSC charter, the CFPSC is to "Assure that all real property and facility plans are coordinated across departments, and in alignment with legislative mandates and County over-arching facility strategies and long-term plans". To address capital requests for facility needs, the CFPSC reviews and provides recommendations on capital requests as part of the capital budget preparation process. This memo is a summary of the CFPSC recommendations for the list of 2023 capital requests.

PROCESS

The CFPSC assembled a Capital Request Review sub-group consisting of the committee coordinator, and designated voting members from two of the County departments on the CFPSC. For review of 2023 capital requests, the sub-group consisted of Peter Nilles (CFPSC committee coordinator), John Blonien (representing the Milwaukee County Department of Transportation), and Vera Westphal (representing the Milwaukee County Zoo). The Capital Request Review sub-group reviewed the facility capital requests as provided by the Office of Strategy, Budget and Performance, and assigned a designation to each of the capital requests as "Recommend", "Not Recommended", or "Hold", based on the CFPSC facility strategies.

The sub-group did not apply a racial equity lens in its review of the projects. The sub-group recognizes that the Office of Strategy, Budget and Performance has requested information from requesting department on racial equity factors for each capital project request, and that the racial equity information will be provided to policymakers separately for consideration.

The sub-group did not review projects submitted to the ARPA Task Force for potential funding from available Milwaukee County American Rescue Plan Act funding.

The sub-group completed its review of the capital requests on May 26, 2022. The full CFPSC reviewed the designations at its June 2, 2022 meeting, modified the designations as it felt appropriate, and endorsed the final designations.

FINDINGS

Most projects have been designated as "Recommend" for the 2023 capital budget. Ten projects were designated as "Not Recommended." Table 1 is a list of those projects that were designated as "Not Recommended", with specific comments from the sub-group providing a rationale for the designation.

Please note, even though capital requests for horizontal assets, such as roads, bridges and trails, are not included in the County's facility condition assessment database (VFA) and do not have an associated building mission category (BMC) score, the Capital Request Review subcommittee has provided a designation for horizontal assets, as those assets do fall under the purview of the CFPSC charter.
