### SCHEDULED ITEMS:

1. Welcome.

Chairwoman Wesley welcomed everyone to the October 24, 2022, Mental Health Board Community Stakeholder Advisory Council's remote/virtual meeting.

2. Granite Hills Hospital and the Mental Health Emergency Center (MHEC) Transportation Resources.

Research was conducted related to transportation resources in the immediate vicinity of the Granite Hills Hospital. It was reported the nearest bus stop is approximately a tenth of a mile away from the hospital. It's located outside of the Pick-N-Save on National Avenue. For individuals who do not have a GoPass, paratransit resources are available as well and can be accessed through Medicaid and Medicare.

The Mental Health Emergency Center (MHEC) has been providing bus tickets and taxi services since opening the facility. There is now an agreement with Kaizen Health, which will allow more options and ensure compliance with applicable laws. Kaizen Health is a technology startup for non-emergency medical transportation with curb-to-curb, door-to-door, and door-through-door access. It networks to serve urban, suburban, and rural markets for people of all physical abilities. An update on the quality of these services will be provided at the next Council meeting.

Questions and comments ensued.

### 3. Members' Outcome Expectations Surrounding the Purpose of the Council.

The forum opened and Council Members expressed their desired goals and accomplishments for the Council. Members shared how their primary motivation is to be able to serve as an advocate and liaison between the clients served and the Mental Health Board. However, questions were raised regarding the Council's level of priority and the power it holds as it pertains to advocacy conducted. The reasoning behind the question posed is to ensure concerns, comments, and/or questions from the community are addressed in a timely manner by all establishments involved, including the Mental Health Emergency Center, Granite Hills, and any other County community services being provided.

This item was informational.

### 4. Council Members' Outreach Updates.

Members have been working to gather feedback on client experiences at both the Mental Health Emergency Center (MHEC) and Granite Hills Hospital. Two experiences, in particular, were shared. A corporate guardian expressed to a Council Member how they were pleased to be able to have direct contact with the physicians caring for their ward during their stay at MHEC. In contrast, there was another corporate guardian who hadn't received that same level of communication from the staff at Granite Hills. Unfortunately, the guardian stated there had been multiple call attempts to receive an update with no response.

The other source of outreach Council Members are eager to obtain are the infographic sheets being developed through the Mental Health Board's Community Engagement Committee.

Questions and comments ensued.

### 5. **2023 Tentative Meeting Schedule.**

A draft meeting schedule for 2023 was reviewed. Initially, upon the Council's conception, it was agreed to meet bi-monthly beginning 2023. After further discussion, the Council decided to continue to meet monthly. This was determined based on needing more time to increase the Council's stamina in the public.

Chairwoman Wesley ordered the meeting adjourned.
