Adoption of a Final Supervisory District Plan map based upon the 2020 Census and Tentative Supervisory District Plan map adopted by the County Board of Supervisors and ward plans adopted by municipalities, by recommending adoption of the following:

AN ENGROSSED RESOLUTION

WHEREAS, U.S. census data needed to begin the decennial redistricting process was not transmitted to Milwaukee County until late August 2021, creating a very compressed timeline for counties and municipalities to complete their redistricting duties; and

WHEREAS, after a lengthy process that included the recommendations of an Independent Redistricting Committee, and many opportunities for public comment, the County Board of Supervisors adopted a Tentative Supervisory District Plan map on October 29, 2021 (File No. 21-994); and

WHEREAS, Milwaukee County’s nineteen municipalities have used the Tentative Supervisory District Plan map to develop the individual wards for their communities; and

WHEREAS, wards established by four municipalities, including Glendale, Greenfield, Milwaukee, and West Allis, require the County Board to slightly adjust the final version of the Supervisory District Plan map; and

WHEREAS, the Southeastern Wisconsin Regional Planning Commission (SEWRPC), who has served as technical advisor to the County’s redistricting process, made the changes to Supervisory District Plan map to reflect the adjustments required due to the development of the municipal ward maps; and

WHEREAS, the Committee on Judiciary, Safety, and General Services, at its special virtual meeting of November 22, 2021, recommended adoption of File No. 21-1091 as amended (vote 4-0); and

WHEREAS, at its meeting on November 22, 2021, the County Board of Supervisors supported moving City of Milwaukee Ward 184 from Supervisory District 10 to Supervisory District 13; and

WHEREAS, the Final Supervisory District Plan map, **as amended to move City of Milwaukee Ward 184 from District 10 to District 13**, is attached to this file, including a link to a high-resolution version of the map; now, therefore,

42 BE IT RESOLVED, pursuant to Wis. Stat. § 59.10, and relevant case law, the
43 Milwaukee County Board of Supervisors hereby adopts the Supervisory District Plan
44 map, **as amended to move City of Milwaukee Ward 184 from District 10 to District**
45 **13**, hereby attached to this file, as the proposed redistricting plan for elections to the
46 Milwaukee County Board of Supervisors for elections beginning in 2022; and

48 **BE IT FURTHER RESOLVED, the County Board hereby adjusts the**
49 **numbering of the districts to flip the numbering of Districts 17 and 9 so District 17**
50 **is District 9 and District 9 is District 17; and**

52 BE IT FURTHER RESOLVED, upon adoption, the County Clerk, working with
53 other officials and staff as needed, shall transmit a certified copy of the Supervisory
54 District Plan map, **as amended to move City of Milwaukee Ward 184 from District**
55 **10 to District 13**, to the appropriate State officials; and

57 BE IT FURTHER RESOLVED, the Research Services Division, Office of the
58 Comptroller, is requested to produce recommended changes to Chapter 3 of the
59 Milwaukee County General Code of Ordinances to comport to the final Supervisory
60 District Plan map, **as amended to move City of Milwaukee Ward 184 from District**
61 **10 to District 13**, for consideration and adoption in the December 2021 meeting cycle.
