REQUEST

Authorization to execute a Permanent Gas Easement with WE Energies under the Root River south of Cleveland Avenue to improve gas service reliability by connecting two existing gas mains.

BACKGROUND

Milwaukee County Parks frequently coordinates with WE Energies for the purpose of utility services both to Parks facilities and across parkland. The current request from WE Energies is to install a gas main under the Root River south of Cleveland Avenue. The purpose is to connect two existing gas mains on the west and east sides of Root River Parkway to improve the reliability of gas services in the surrounding area. The proposed gas main would be installed using directional boring with open excavations on the east and west sides of the parkway.

Parks has reviewed this request and based on the size of the easement, the minimal impact to parkland, natural areas, and recreational activities, and the overall benefit to the community as it relates to improving system reliability for gas customers in the area, is recommending

approval of this easement. Using comparable land values, WE Energies is offering \$3,072 for the proposed easement rights.

New services are installed by WE Energies and their contractors, and permission for installation work is granted through the Parks Right-of-Entry permit process. Granting the permanent easement is necessary for the long-term operation of the utility on Park property and requires authorization from the Milwaukee County Board of Supervisors and the County Executive.
