A. The Director of the Department of Health and Human Services (DHHS) is requesting authorization to execute 2022 Housing Division purchase of service contracts with community vendors.

Approval of this request will allow the Director of DHHS to execute purchase of service contracts to continue provision of contracted Emergency Shelter Care, Permanent Supportive Housing Development Support Services, Supported Apartments, Shelter Plus Care Supportive Services, Peer Support Program, Right to Counsel, and Homeless Case Management for the period January 1, 2022 through December 31, 2022. The contract with Pathways to Permanent Housing Program will be effective from January 1,2022 through March 31, 2022 pending final resolution of a Request for Proposals (RFP) process.

- B. Total 2021 expenditures included in this request are \$5,522,670.
- C. There is no tax levy impact associated with approval of this request in 2022 as funds sufficient to cover associated expenditures are included as part of Housing's 2022 Budget.
- D. This fiscal note assumes expenditures will not exceed the amounts authorized for these purchase of service contracts.
