DESCRIPTION OF FISCAL EFFECT

The approval of the requested action will allow the Director and Chief Information Officer of the Department of Administrative Services – Information Management Service Division (DAS-IMSD) to waive of Section 9.05 (3) (a) of the Ethics Code. This waiver will allow Jason Thomas to become DAS-IMSD contracted staff through a temporary agency after leaving Milwaukee County employment as an intern.

The direct costs involved for hiring Jason Thomas as a contractor are approximately \$1,120.00 per week (based on an hourly rate of \$28.00 per hour), with this being funded through the 2022 DAS-IMSD Operating Budget.
