SECTION 1. Section 17.98 of the General Ordinances of Milwaukee County is amended as follows:

17.98 Salaries of constitutional and statutory officers.

The positions of constitutional officers within Milwaukee County include the following: sheriff, clerk of circuit court, county treasurer, register of deeds, and the county clerk. The position of comptroller is a statutory officer. It is recognized that the incumbents of these positions serve as the department head and manager of their respective functional area and thus should be compensated accordingly.

Consistent with s. 59.22(1)(a), Wis. Stats. salary levels for the constitutional officers shall be established before the earliest time for filling nomination papers for the office, namely, before April 15 of the year in which the general election for these positions is to be held.

Consistent with s. 59.22(1)(a), Wis. Stats, the salary level for the position of comptroller shall be established before the earliest time for filing nomination papers for the office, namely, before December 1 of the year immediately preceding the year in which the general election for the position is to be held.

Salary for the position of comptroller for the term for which the general election will be held April 57, 201620, is set at one-hundred twenty-five forty thirty thousand dollars (-\$-1-2-5--0-0-0-0-0) (\$140,000,00\$130,000,00) annually.

In the event no action is taken with respect to the salary levels by the specified dates, the salary levels shall continue as previously established.

SECTION 2. The provisions of this ordinance shall be effective upon passage and publication.
