I. CALL TO ORDER AND ROLL CALL – present

Chair Pitchford-Nicholas called the Senior Center Select Committee to order on Tuesday, November 2, 2021, at 1 p.m. DHHS Division on Aging's Program and Policy Coordinator Dan Idzikowski took roll call.

III. TRANSLATING THE FUTURE OF SENIOR CENTERS VISION STATEMENT INTO ACTION

Gene Guszkowski presented and discussed the vision statement that he and Howard Snyder authored with the committee. The Committee discussed possible next steps to move forward with the draft statement. A few committee members felt they needed to receive more input from the public on the progress of the visioning statement before submitting the final report to the Commission on Aging. The Senior Center Select Committee will present the draft vision statement to the Commission on Aging in its current draft state.

Chair Pitchford Nicholas requested that Gene Guszkowski and Howard Snyder present the draft Senior Centers vision statement to the Commission at the November COA meeting.

The Senior Center Select Committee broke into their subcommittees to discuss the seven critical questions for the Select Committee on Senior Centers document among their group members. They will report back at the next Senior Center Select Committee meeting.
