From the Milwaukee County Ethics Board recommending amendments to Sections 9.03 and 9.04 of the Milwaukee County Code of General Ordinances to remove the requirement for individuals to file a notarized Affidavit with their Statement of Economic Interests form and replace it with a declaration item at the end of the Statement of Economic Interests form, by recommending adoption of the following:

A RESOLUTION/ORDINANCE

WHEREAS, the Code of Ethics (Ethics Code), contained in Chapter 9 of the Milwaukee County Code of General Ordinances (the Code), requires all Milwaukee County (the County) elected and appointed officials, candidates for elected County offices, and certain County employees (filers) to file a Statement of Economic Interests (SEI) form upon declaring their candidacy or entering County service as well as annually with the office of the County Ethics Board; and

WHEREAS, Section 9.03(5) of the Code requires SEI filers also file a sworn Affidavit regarding their compliance with the Ethics Code; and

WHEREAS, said requirement creates an undue burden for the filer to locate and obtain notary services (potentially at personal expense), which has been exacerbated by the ongoing public health crisis; and

WHEREAS, the language of the Affidavit can be incorporated into the SEI form as part of a "declaration item" where individuals can confirm their compliance with the Ethics Code and complete their submission; and

WHEREAS, eliminating the Affidavit requirement brings the County's Ethics Code closer in line with the Codes of Ethics for the City of Milwaukee and the State of Wisconsin, neither of which require an Affidavit be filed with an individual's financial disclosures; and

WHEREAS, eliminating the Affidavit requirement allows the Ethics Board's office to streamline the filing process as it migrates to a digital portal; and

WHEREAS, the Committee on Judiciary, Safety, and General Services, at its meeting of December 2, 2021, recommended adoption of File No. 21-1034 (vote 5-0) now, therefore,

BE IT RESOLVED, the Milwaukee County Ethics Board and its Executive Director recommend that the Milwaukee County Board of Supervisors hereby amend Chapter 9 of the Milwaukee County Code of General Ordinances, by adopting the following language:

50 **SECTION 1.** Section 9.03 of the Milwaukee County Code of General Ordinances is

63 in the service of the county shall submit to the executive director of the ethics
64 board an updated list of the job titles and position numbers of those incumbents
65 within his/her jurisdiction. He/she shall indicate on the list whom, in his/her
66 opinion, should be required to file statements of economic interests and sworn
67 affidavits.

69 **SECTION 2.** Section 9.04 of the Milwaukee County Code of General Ordinances is
