Attorney Zolik,

I write at the direction of the Milwaukee County Board of Supervisors to request the Attorney General's opinion "on the constitutionality of 2013 Wisconsin Act 14 in 129 light of the Voting Rights Act of 1965." See County Board Resolution 21-76 at lines 127-130.

Attached you will find 5 items relevant to the request:

- 1. Resolution 19-707, which requested from my office an opinion regarding whether 2013 Wis. Act 14, 2013 Wis. Act 203, and/or 2015 Wis. Act 55 (the "Acts") violate the Civil Rights Act of 1964.
- 2. Our opinion in response to that resolution.
- 3. Resolution 21-76, which requested from my office an opinion regarding whether 2013 Act 14 violate the Voting Rights Act of 1965.
- 4. Our opinion in response to that resolution.
- 5. Resolution 21-844, which directs the retention of outside counsel to address the question posed in resolution 21-76.

Please note that both orally and in both of our written opinions, my office advised the County Board of Supervisors that the Attorney General's office does not issue opinions relating to the exercise of legislative or executive judgment should not be requested, nor will the AG issue opinions regarding the applicability of federal statutes and regulations administered by federal authorities (*see* 77 Op. Att'y Gen. Preface (1988), attached as Exhibit A to our REPORT in response to File 19-707). We also respectfully note this passage from the relevant AG guidance: "A question should not be submitted simply because someone wishes it submitted. A question should

not be submitted unless, after having given the problem careful consideration, a satisfactory legal answer cannot be reached." Id. at 1. We believe a correct and reliable answer has been provided, however, the County Board did adopt resolution 21-578, which directs Corporation Counsel to request the opinion.

Given that the County Board is contemplating spending up to \$25,000 on outside counsel, we would be most grateful if a response to this request for an opinion, in whatever form the Attorney General deems appropriate, be submitted as soon as possible. Please note that resolution 21-844, related to outside counsel, will be heard next Thursday, September 9.
