9	WHEREAS, Section 46.031, Wisconsin State Statutes, requires that Milwaukee
9 10	County enter into a contract with the State of Wisconsin (the State) Department of
10	Health Services for social services and community programs (otherwise referred to as
12	Community Aids); and
13	
14	WHEREAS, the State has provided notification of funding in 2022 for social
15	services and community programs; and
16	
17	WHEREAS, one of the largest revenue sources for the Department of Health and
18	Human Services (DHHS) are State and Federal funds that are forwarded to the
19	Department under the Social Services State Contract (the Contract), which funds
20	programs in the Aging and Disabilities Services Division, Housing Division, and
21	Behavioral Health Division; and
22	WILLEDEAS, the actual 2022 Community Aide Contract for DILLIS provides a
23 24	WHEREAS, the actual 2022 Community Aids Contract for DHHS provides a 2022 allocation totaling \$17,193,695, and this amount is \$78,715 more than the
25	\$17,114,980 included in the DHHS 2022 Budget; and
26	
27	WHEREAS, this is primarily due to increased funding for Alzheimer Caregiver
28	Support, and a variety of Title 3 funding increases offset by less Children's Long-Term
29	Support (CLTS) Program administration revenue, due to a lagging assumption on the
30	number of children being served in the program; and
31	WHEREAS it is in Milwaukas County's (the County) hast interact to execute
32	WHEREAS, it is in Milwaukee County's (the County) best interest to execute contracts in a timely manner to improve cash flow and maximize interest earnings; and

35	WHEREAS, the County will not receive any State Community Aids revenue until
36	the Milwaukee County Board of Supervisors has authorized the Director, DHHS, to
37	execute the Contract; and

39	WHEREAS, the Committee on Finance, at its meeting of December 9, 2021,
40	recommended adoption of File No. 21-1017 (vote x-x); now, therefore,

BE IT RESOLVED, the Director, Department of Health and Human Services 42 (DHHS), or her designee, is hereby authorized to enter into a contract (and any 43 addendum thereto) with the State of Wisconsin (the State) Department of Health 44 Services, covering social services and community programs for the period beginning 45 January 1, 2022, through December 31, 2022, in the amount of \$17,193,695; and 46 47 48 BE IT FURTHER RESOLVED, of the \$17,193,695 in State Community Aids
