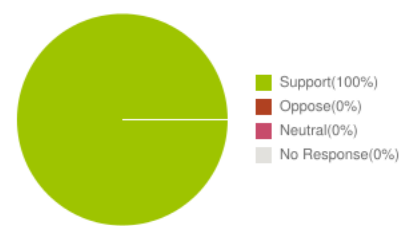

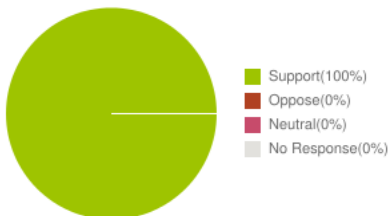

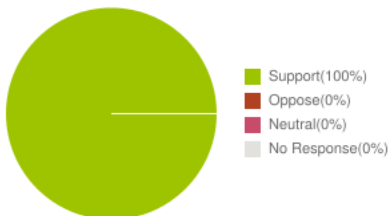

This is a landmark in Milwaukee county and a historical building in honor of the dedication that Del Porter gave to this community.
