The Board of Supervisors of the County of Milwaukee does ordain as

SECTION 1. Chapter 112 of the General Ordinances of Milwaukee County is created as follows:

112.01. Policy It shall be the policy of Milwaukee County to establish a Voter Registra-tion Program ("VRP") to allow Milwaukee. County≥ residents to register to vote for local state, and federal elections at designated locations where they apply for renew or update information for the receipt of services, delivered by Milwaukee

112.03. Special Registration.

Deputy Requirements Employees trained as Special Registration Deputies (SRDs) by the City of Milwaukee shall obtain SRD confirmation from each of the participating municipals clerks in the manner and to the extent required by each municipality.

112.04. Accountability, enforce-

menta and monitoring
(1) The VRP sites designated in section 112.02 shall offer voter registration to Ecitizens applying for benefits, recertifying their eligibility.

or changing their address.
(2) Reception area staff for each designated VRP site shall inquire whether the citizen wishes to register to vote. If the citizen expresses interest in the VRP, staff members shall provide each interested person with a VRP packet and shall contact the office SRD to conduct the citizen's voter registration. The VRP packet shall consist of the following

office.

(5) For those Milwaukee County municipal clerks' offices that do not recognize SRDs: SRD staff at the designated VRP sites shall provide a citizen interested in registering to vote with the VRP packet and appropriate municipal clark's address and priate municipal clerk's address and

recister at that location.

SECTION 2. The provisions of this ordinance shall be effective upon passage and publication.
